## A V Nachane (General Secretary of the All India Life Insuarance Employees Federation)

A short biographical note on A V Nachane interviewed on June 18, 2003 in Mumbai by Krishna Jha at the office of LIC Employees Union.

I was born on July 5, 1934 in a Bombay suburb. My father was a gold medalist, successful advocate and editor of his own newspaper. My brother was in Rashtra Sewa Dal of SM Joshi and I used to accompany my brother in Dal activities though too young.

I studied in Bomabay and when I was in college I came to know SA Dange, SM Joshi and others who left a deep impression on me.

After graduation, I joined Life Insurance Company in 1955 and joined Sanyukta Maharashtra Movement. It was the first strike I experienced and was deeply influenced by SA Dange. Another person to impress me was Achrya Atre.

In 1955 general strike, trade unions and communists were in fore front. There was "Shoot at Sight" order by the Morarji Government and 100 persons were killed in the process.

By this time second five year plan was taken up and the process of nationalisation was also started. On September1, 1956, Life Insurance Company came into being merging 257 companies.

In 1956, a decision was taken to call for general strike which was supported by the socialists in the union. SM Joshi had the casting vote. Dange was not in the Action Committee. Government of India took it as a challenge. However a token strike of one day was observed in solidarity of general movement in Bombay. However, the LIC management was in the hands of the IAS officers who insisted on throwing away the union office bearers but could not.

In 1968, a struggle against automation was launched which had already started in 1965. By this time, the Communist party was split and the two groups were criticing each other. By November 14, there was a split in LIC union too and 75 percent of the workers came with AITUC.

I am the general secretary of the All India LIC Employees Federation. I believe that every trade unionist should struggle against the bourgeosie and work in a public sector.
